Environmental: Water loop refrigeration technology / Season Refrigeration Pte Ltd*	\$ 455,412.78	We recognise the impact of energy usage in our operations and are committed to reduce our emissions and energy consumption. With the understanding of our customers' interest in environmental issues and sustenance of the planet, we are taking important steps to invest in pioneering new technologies such as water loop refrigeration technology and using refrigerants with a lower global warming potential (GWP) where possible. In 2024, we invested in developing and installing water loop refrigeration technology, enhancing the efficiency of our systems and reducing energy consumption at our supermarkets at Pasir Ris Mall, Chancery Court, Tengah Plantation Plaza and New Bahru. We were able to reduce the average carbon emission per store by up to 237,062 ktCO ₂ e. We continue to expand our knowledge and expertise to make meaningful strides to benefit both the business and the communities we serve.
